THIS DECLARATION OF TRUST made and executed this Twelfth day of June, 1974 by (1) Mr.N.Soundarajan, Son of Sri G.T.Narayanaswamy Naidu, aged about 42 and (2) Smt.Saroja Soundarajan, Wife of N.Soundarajan aged about 38 and residing at "Lakshmi-Soundara", G.T.N.Naidu Salai, Dindigul-624004 hereinafter called the Settlers - Trustees of the First Part in favour of the Board of Trustees comprising of:

- 1) Sri N.Soundarajan and
- 2) Smt.Saroja Soundarajan

WHEREAS the Settlers out of philanthropic consideration are desirous of creating a Public Trust in order to carry out certain charitable purposes more particularly set out in the clauses following:

WHEREAS the Settlers are desirous of starting the Trust with an initial contribution of Rupees One Thousand only by each of them totalling to Rupees Two Thousand only which shall form the nucleus of the Trust properties;

WHEREAS the Trustees have agreed to accept the said amount and to take over the said amount together with other properties that may be settled in Trust from time to time for the purposes and in the manner hereinafter appearing;

NOW THIS DEED WITNESSETH as follows:-

1. The name of the Trust shall be Soundararaja Charities Trust, Dindigul.
2. The objects of the Trust are:

1. To relieve the poor and indigent men and women of all communities without any restriction as to caste, community and creed including constructing, maintaining choultries, public halls, for the benefit of the public free of charge and to feed poor and needy.
